### Methods and materials for containment and cleaning up

#### **Small spill**

**Stop** leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. ### Precautions for safe handling

#### Protective measures

## Section 8. Exposure controls/personal protection

### Hygiene measures
