HANDLING

Avoid breathing mists or vapors. During quenching operations, these oils are heated to very high temperatures. Under such extreme conditions, certain toxic/carcinogenic contaminants can be formed in the cracking process of

the oil. These substances, polycyclic aromatic hydrocarbons (PAC or PNA) can impart a cancer potential to the oil that did not exist prior to use in the quenching process. These contaminants may increase in concentration during service life, depending on the degree of use and the rate of replenishment with fresh oil.

Prevent small spills and leakage to avoid slip hazard. Material can accumulate static charges which may cause an electrical spark (ignition source). When the material is handled in bulk, an electrical spark could ignite any flammable vapors from liquids or residues that may be present (e.g., during switch-loading operations). Use proper bonding and/or ground procedures. However, bonding and grounds may not eliminate the hazard from static accumulation. Consult local applicable standards for guidance.
